We continue to monitor the status of COVID19 (Corona Virus) and its impacts our area. As of this writing, we have no documented reports of the virus at Sandestin, within the SOA or Walton County. To that extent, we are operating as recommended by State and Federal health agencies; Florida Department of Health (DOH), Center for Disease Control (CDC), World Health Organization (WHO), and the United States Department of Labor (USDOL).

All agencies generally recommend the same precautions, stay home if ill, avoid contact with sick people, practice good hygiene, avoid touching your face, and avoid unnecessary crowd gatherings and non-essential travel, particularly foreign.

According to the CDC, some steps you can take as a mitigation strategy if you are feeling ill are simple.

- Stay home if you are sick
- Contact your healthcare advisor in advance of a visit
- > Limit movement in the community
- Avoid visitors

You should also create a household plan of action in case you are impacted by illness.

- Ensure you have at least a 2 week supply of your medicines
- > Establish ways to communicate with family, friends, and co-workers other than face to face contact
- Know what to do about childcare needs, and how to adapt to cancellation of events or appointments
