


CROSSWALK RELOCATION

11/2019 - Board reviewed a draft plan to relocate the Baytowne Ave crosswalk north to be adjacent to the Hummel Aquatic Center entry. A revised plan will be done to add an extension of the sidewalk along Baytowne Ave to the St. Andrews entry. RFP's will be sent out upon completion of Option 2.

5/2020- BOD approved \$203K from Undesignated Capital Contributions, RBM as the contractor, project is scheduled to commence after Labor Day/closure of the tunnel is not expected for this project.






11/21/19 Board approved \$60K to replace the pedestrian beach access between the Hilton and The Beach House with composite material and a new ramp to meet ADA requirements.


WEST PERIMETER FENCE
