The parade will begin at 9 am at Mike Hayes Blvd (by the tennis courts) and end at the Village of Baytowne Wharf event lawn. The meeting place for the parade will be at Embarc (formerly Club Intrawest). Decorators and decorations will be available beginning at 8:00 am at the north corner of the Embarc parking lot for those that would like assistance in getting ready! If you will be decorating on your own, arrival time will be 8:40 am in the Embarc parking lot. After the parade, participants and parade goers will gather for kid’s activities such as water slides, face painting, and arts & crafts, along with snacks and awards for the best decorated cart!

Rules/Regulations:

1. Golf cart must be decorated in a patriotic theme.
2. Must complete and submit a registration form and signed release form to participate.
3. Golf cart must be registered with the SOA (or considered a service vehicle).
4. Driver must have a license and be at least 16 years old.
5. All passengers must have a seat.
6. Participants are encouraged to have a supply of “throws” and may have music on cart.
7. Bicycles and walkers are welcome but must sign a release form.
