The parade will begin at 9 am at Mike Hayes Blvd (by the tennis courts) and ends at the Village of Baytowne Wharf event lawn. The meeting place for the parade will be at the Hilton Grand Vacation (formerly Embarc) parking lot. Decorators and decorations will be available beginning at 8:00 am in the corner of the parking lot for those that would like assistance in getting ready! If you will be decorating on your own, arrival time is 8:30 am. After the parade, participants and parade goers will gather for this Birthday Bash including kid’s activities such as water slides and face painting, along with snacks and awards!

Rules/Regulations:

1. Golf cart must be decorated in a **patriotic/birthday** theme.
2. No marketing/advertising is permitted, as decorations or throws.
3. No political messages, decorations, or throws are permitted.
4. Must complete and submit a registration form and signed release form to participate.
5. Golf cart must be registered with the SOA (or considered a service vehicle).
6. Driver must have a license and be at least 16 years old.
7. All passengers must have a seat.
8. Participants are encouraged to have a supply of “throws” and may have music on cart.
9. Bicycles and walkers are welcome but must sign a release form.
